Dear Parents,

In the event of a school closure or tighter lockdown restrictions it is possible that the school will only be open to vulnerable children; that is those who have an Education and Health Care Plan, those who have a Social Worker, and children whose parents are classed as a critical worker.

To ensure the safety of our children and staff we will only be able to accommodate a maximum of 15 children per class (not year group). Spaces will be prioritised as follows:

- Children with an Education and Health Care Plan

- Vulnerable Children

- Children of Critical Workers working in:

  - Social Care

  - Health

  - Education or Childcare

  - Public Safety ie Police, Fire etc

  - Food and other necessary goods – manufacture and distribution

  - Utilities and financial services

Once a total of 15 children per class is reached we will be unable to offer further places. Attendance at School in any of these groups is as a last resort and only if no other arrangements can be made.

Please complete the attached slip below, or email the school on [admin@littledean.gloucs.sch.uk](mailto:admin@littledean.gloucs.sch.uk) if you feel that your child(ren) may require a place at school indicating the appropriate category. Proof of employment may be requested.

Should we enter another lockdown period where school is closed for the majority of children we will once again post remote learning on the school website, [www.littledeanprimary.co.uk](http://www.littledeanprimary.co.uk). We are aware that the majority of our families have access to suitable IT equipment that enable them to access the website and download videos and online learning platforms, some may not.
